We provide you with information regarding the processing of your personal data by RWE Renewables Poland Sp. z o.o., with its registered office in Warszawa in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (OJ L 119, p. 1) – the GDPR, in connection with the video surveillance of the wind / photovoltaic farm.

Purposes of data processing, legal basis and legitimate interests of the controller	<ul> <li>Your personal data are processed for the following purposes:</li> <li>to ensure the safety of persons and property on the building site - because the processing is necessary for us to pursue our legitimate interest (Article 6(1)(f) GDPR), which is to be able to ensure the safety of persons and property on the construction site;</li> <li>to make recordings available to persons affected by a possible incident on the building site recorded by video surveillance - because the processing is necessary to pursue third party's legitimate interest (Article 6(1)(f) GDPR), which is to be able to exercise legal claims related to an incident on the building site;</li> <li>to establish, exercise or defend legal claims relating to incidents on the building site recorded by video surveillance or to the processing of your personal data – because the processing is necessary for us to pursue our legitimate interest (Article 6(1)(f) GDPR), which is to be able to exercise legal claims relating to exercise our defend legal claims relating to incidents on the building site recorded by video surveillance or to the processing of your personal data – because the processing is necessary for us to pursue our legitimate interest (Article 6(1)(f) GDPR), which is to be able to establish,</li> </ul>

Information about automated data processing / profiling	Your personal data is not processed by automated methods or profiling.
Categories of data recipients	<ul> <li>The recipients of your personal data may be entities in the following categories:</li> <li>companies that are members of the RWE group;</li> <li>security company that manages the video surveillance system;</li> <li>persons who prove a legitimate need for access to the recordings (a third party's legitimate interest), such as those affected by situations recorded by the video surveillance;</li> <li>purchasers of receivables;</li> <li>business information agencies;</li> <li>providers of the following services: mail and parcel delivery services, printing and archiving services, IT and new technology services, telephone or e-mail services, accounting and financial services, audit and controlling services, legal and debt recovery services.</li> </ul>
Transfers of data outside the European Economic Area	RWE Renewables Poland outsources individual services and tasks to selected service providers based outside the European Economic Area (in a "third country"), in particular IT service providers. In such cases, the data are transferred to a third country on the basis of a decision of the European Commission determining an adequate level of protection or, in the absence of such determination, in accordance with legal requirements, appropriate safeguards are applied to create an adequate level of data protection - these include in particular the EU standard contractual clauses. You may request at any time further information and receive a copy of the relevant safeguards.
Data retention period	Your personal data will be processed for a period of 3 months from the date of recording, but no longer than until you lodge an objection. In the case of an incident on a building site recorded by video surveillance and the pursuit of related claims, your personal data will be processed for the period necessary to initiate and execute proceedings at the relevant authority (police, courts).
Your rights	<ul> <li>You have the right:</li> <li>of access to your personal data, to the restriction of their processing or to their erasure;</li> <li>To exercise the above rights, please contact RWE Renewables Poland Sp. z o.o. or the Data Protection Officer. The contact details are given above.</li> <li>You also have the right to lodge a complaint with the supervisory authority competent for personal data protection if you consider that the processing of your personal data violates the GDPR.</li> </ul>



Right to object	<ul> <li>You have the right to object at any time to the processing of your personal data for the purpose of pursuing one or more of our legitimate interests, which are: <ul> <li>ensuring the safety of persons and property on the building site;</li> <li>making recordings available to persons affected by a possible incident on the building site recorded by video surveillance;</li> <li>establishing, exercising or defending legal claims.</li> </ul> </li> <li>The reason for the objection must be your particular situation. After we have received your objection, we will stop processing your data for the purpose or purposes to which you have objected, unless we demonstrate that there are compelling legitimate grounds for the processing which override your interests, rights and freedoms or grounds for the establishment, exercise or defence of legal claims.</li> <li>To exercise the right to object, please contact RWE Renewables Poland Sp. z o.o. or the Data Protection Officer.
